Master's in Educational Supervision

Program Overview

The Master's Program in Educational Supervision aims to prepare research students who have earned a master's degree in educational supervision to provide educational institutions with professional cadres specialized in the field of educational supervision capable of writing academic and scientific articles at the graduate level in social and human sciences, such as reflective and critical reflective articles. The program encompasses literary references, abstracts, research reports, and diverse forms of analytical writing. Understanding the intended content and making a qualitative shift in educational institutions through writing tasks, oral presentations, and dialogue is crucial. This is achieved through intensive reading, interaction with various technological sources, familiarity with modern educational supervision methods, and evaluation of the

performance of educational institution employees. The program also focuses on enhancing Jordan's educational supervision system, assessing the effectiveness of educational science in both active and inactive schools, and utilizing principles, standards, and techniques to create professional development plans and programs for educational institution staff. The program also aims to prepare researchers with advanced and independent research skills to conduct qualitative and quantitative scientific studies in various areas of educational psychology.

• Students demonstrate the ability to apply theoretical and practical skills and experiences, plan and implement administrative programs, and develop teaching and mentoring skills that enable them to provide support and guidance to teachers and educational workers.

• Students demonstrate the ability to communicate positively with the educational field, develop skills to deal with diversity in teaching environments, and improve the learning experience for all students.

Program Importance

The importance of the program lies in providing educational supervisors with the knowledge and skills necessary to improve the quality of education through effective teacher support and the development of innovative educational strategies. The program enhances supervision and mentoring capabilities by promoting effective teaching, which contributes to improving students' academic performance. It also encourages critical thinking and scientific research in education. This helps to implement innovative educational practices and create integrated learning environments. The program prepares graduates for leadership positions in education and fosters collaboration and communication between teachers and management to ensure that educational goals are achieved.

Targeted Groups and Accepted Majors

Applicants are required for admission to this program:

1. Meet the requirements set out by the Higher Education Council.

2. The bachelor's degree in a subject qualifies him for specialized study in the department he wishes to enrol in, according to the principles decided by the department.

3. Meet the necessary language requirements to enrol in the program, following the Council of Higher Education's decisions.

4. The relevant committees and councils have approved any other conditions.

Job Areas

The program graduate can find employment as a(n):

1. Educational Supervisor in schools and educational supervision departments of the Ministry of Education, private schools, and UNRWA schools.

2. expert competent in the areas of planning and development of the institutions and centers concerned in this field.

3. Director of educational development projects in civil, international, and community institutions and organizations.

4. educational initiative capable of putting forward educational initiatives and leading them to achieve their goals.

5. faculty member in universities or administrative in institutes and colleges.

Credit Hours and Tuition Fees

The Master's program requires students to complete 33 credit hours.

The cost per credit hour is:

- Jordanian students: 70 Jordanian Dinars.
- Non-Jordanian students: 225 US Dollars.

Study Plan Overview

A master's degree is awarded in the field of Educational Supervision after completing the following requirements:

1. Fulfilment of the degree requirements.

2. Completion of any remedial courses determined by the Graduate Studies Committee in the department.

3. Completion of a minimum of 33 credit hours at the 600 level, with successful completion and a cumulative GPA of no less than 75%.
