# Master's in Public Law

# **Program Overview**

The Master's Program in Public Law, with tracks of Criminal Law and Administrative Law, is a program offered by the College of Law at Yarmouk University in response to the need of the local and Arab market to provide it with specialized legal competencies in public law. Success in this program requires studying (33) credit hours distributed between compulsory requirements and elective requirements in addition to the comprehensive exam, where the student studies a common package of compulsory courses, while the student's precise specialization in criminal law or administrative law is determined through the optional courses that he studies from the hours allocated to each path and through the subject of the message if he is approved for transfer to the message system if the legally specified conditions are met.

## **Program Objectives**

The Master of Public Law program aims to:

- 1. Preparing jurists equipped with advanced knowledge in public law with a focus in one of its branches, criminal law or administrative law.
- 2. Preparing jurists capable of applying this knowledge in complex cases and criticizing current legal solutions while adhering to the values of justice and the rule of law.
- 3. Developing skills related to analyzing legal problems at the level of public law and finding appropriate solutions within a sound legal framework.
- 4. Strengthening scientific research and legal studies within a sound methodological plan that reaches logical results and recommendations that are applicable in practice.

#### **Program Importance**

The importance of this program appears in the fact that it contributes to preparing a generation of jurists equipped with advanced knowledge in one of the branches of public law and able to apply this knowledge practically, as well as providing the local and Arab community with qualified cadres capable of practicing legal work professionally in all legal fields, especially the judiciary, the law firm, and providing consultations. Legal, and to complete studies and research in various legal fields.

#### **Targeted Groups and Accepted Majors**

- 1. Holders of a bachelor's degree in law or its equivalent who wish to continue their studies in the master's program.
- 2. Lawyers, judges and state employees.
- 3. Arab students who hold a bachelor's degree in law/law.

#### **Job Areas**

- Working as a lawyer in law firms independently or within law firms.
- Working for insurance companies and offices in the field of writing contracts, providing legal consultations, and working in administrative fields.
- Working as a legal advisor to companies, factories and private institutions.

#### **Credit Hours and Tuition Fees**

The plan consists of (33) credit hours

- The price of a credit hour for a Jordanian student: 70 Jordanian dinars
- The price of a credit hour for an international student: 225 US dollars

### **Study Plan Overview**

The study plan for the Master of Public Law consists of (33) credit hours distributed as follows:

- Compulsory specialization requirements:
  - 24 hours for the comprehensive course, in addition to the comprehensive exam
  - 15 hours for the message route, in addition to 9 hours for the message route
- Elective specialization requirements. 9 hours chosen by the student from a package of courses in the Administrative Law and Criminal Law track.
